In Maryland, you are required by law to take a classroom course entitled "Principles & Practice of Real Estate." The tuition and length of this course will vary with the institution. This course covers all the technical aspects of real estate--math, law and theory.

TUITION REFUND POLICY

Montgomery County Regional (Kentlands): Take I-495N/Capital Beltway toward Frederick/ Baltimore. Keep left to take the I-270 N via exit 38 toward Frederick. Take I-270 N. to EXIT 9-B, toward SAM EIG HWY, on the ramp bear to the LEFT toward SAM EIG HWY. Turn SLIGHT RIGHT onto MD-119 W/GREAT SENECA HWY. Turn LEFT onto KENTLANDS BLVD, the building is on the right.

Baltimore Regional (Lutherville): From Columbia take 95N to the Baltimore Beltway 695 toward Towson (this is a left exit). Stay on 695 to Exit 25 which is Charles Street (RT 139). Turn left on Charles Street, at the traffic circle; take the third exit onto Bellona Avenue. Long and Foster is the 1st drive on the right. The training center is on the first floor.
